2. Approval of 2019 Tax Levy

Tax Levy

Mr. Grossi stated there were no changes since presenting the tentative budget at the November Board Meeting. Due to the CPI increase, the district will receive \$306,000 in additional tax revenues. The district levied for a 4.96% increase verses the previous year which left us under the 5% threshold that would require a public hearing for our tax levy. The district collects about 97% of its taxes. The next action item is a resolution for our deficiency levy; we have been doing this for the past three-four years. What we are able to do in Kankakee County is levy for all of the bond and interest money that we do not collect due to lack of payments. The district calculates how much money we do not collect just for the bond and interest fund which was \$69,000 this past year, so we are able to levy for that 69,000 so we can continuously pay our debt in full. Mrs. Wells asked if there were any questions from the Board. Mr. Bohlen asked if this reflected any new increments. Mr. Grossi said no.

Bohlen asked to vote for Action items 2 & 3 together. no objections

3. Consideration and Action on a Resolution Authorizing, Directing, and Certifying a Supplemental Levy to the Kankakee County Clerk, Sufficient to Pay the Interest on Certain Bonds of the District
