She said ExceleRate Illinois is a statewide quality recognition and improvement system designed to make continuous quality improvement an everyday priority among early learning providers. It provides a framework for early learning professionals to identify opportunities for improvement, increase their skills and take steps to make positive changes. ExceleRate Illinois uses a consistent set of standards and conducts on-site assessments for verification of classroom quality. Based on their most recent monitoring results, the district's PFA Program and Proegler School have both achieved the Gold Circle of Quality.
