affiliate must meet or exceed all 17 Essential Requirements, and meet at least 75% of the additional Parents as Teachers Quality Standards. First Taste has met or exceeded all 17 Essential Requirements and met 90% of the Quality Standards.

Being named a Blue Ribbon Affiliate affirms that First Taste is a high-quality member of the home visiting field, implementing the evidence-based Parents as Teachers model with fidelity. Families in the Kankakee County community are positively impacted by the services delivered by this program, which includes home visits, group connections, child screening and connections to community resources, equipping parents with knowledge and resources to prepare their children for a stronger start in life and a greater success in school.

To earn Blue Ribbon Affiliate status, First Taste underwent a rigorous self-study and National center review process to confirm that they are meeting Parents as Teachers' standards of fidelity and quality. Blue Ribbon Affiliates are exemplary programs, delivering highest quality services to children and families. Implementation with quality and fidelity is vital in home-visiting programs as it determines a program's effectiveness in accomplishing its original goals and intended outcomes. It also verifies that a program is being implemented as designed. Parents as Teachers rigorous endorsement process demonstrates an affiliate's accountability and credibility to the community, its funders, elected officials and the partner organizations with which they work.

#### 2. Kankakee Fire Department

Dr. Walters introduced Fire Chief Schuldt from the Kankakee Fire Department who presented a "Safe School" traveling trophy to Kennedy Middle Grade School. Congratulations to the Kennedy staff and students for receiving this award. This school showed the most improvement during the fire drills on the time it takes them to exit the building.

#### 3. COPS Grant

➤ Dr. Walters was excited to announce that the U.S. Department of Justice recently announced the cities that received the 2018 COPS School Violence Prevention Program grant. The City of Kankakee received \$500,000 to be used for safety improvements at the district's school buildings.

#### Principal's Report - Mr. Terrence Lee, Principal of Taft

Mr. Lee reviewed Taft's school improvement goals:

- > School Goal 1: Taft teachers will further develop and implement multi-tiered systems of support for all students for a productive future beyond high school.
- School Goal 2: Taft will build a positive public perception through consistent communication to all stakeholders regarding the District's work with teachers, parents, students, and community members on conflict resolution, safety, health, and well-being.
- School Goal 3: Taft teachers will develop an effective system of communication including roles and responsibilities, expectations and procedures that will support, encourage and retain effective teachers.

Mr. Lee highlighted the procedures put in place to meet their goals. He also touched upon other highlights, which included: Kindergarten Round Up, Daddy/Daughter Dance, Muffins for Mom, Donuts for Dad, Grandparent's Day Tea, Mother/Son Dance, fundraisers, school dances, and after school events.
